- Strong understanding of the importance of Social Dialogue;
- Experience in EU financed projects;
- Continuous contact with the partner COTRAF and the EU Delegation in Kigali;
- Drafting ToRs for consultation services related to the SD4SD EU-Project with partners and guiding resource persons;
- Implementing of programs related to the SD4SD EU-Project with FES partners in Rwanda;
- Monitoring and analyzing of the development of relevant FES Activities related to the SD4SD EU-Project within Rwanda. This includes maintaining contacts with partners and general research of relevant policy;
- Quality insurance evaluation of all activities related to the SD4SD" EU-Project;
- Preparation, implementation, monitoring and review of project budgets and oversight of program logistics related to the SD4SD EU-Project;
